

PUBLISHING SERVICE

Production fee: The production and publishing fee is **\$500.00**

Proofreading: To determine if any areas of the book need work, and work with the Author discussing any revisions.

{Editing: Not included in the publishing fee} Editing charge is .02 cents per word.

Layout / Cover: We create cover designs, but you can use artwork you have already selected for your book's cover.

Production Time: The time frame to publish is 3-5 weeks without complications or changes made to the book. After receiving your material we'll let you know whether any modifications should be made before publishing. The publisher is not responsible for delays beyond its control.

Prepare your manuscript: We need a single Microsoft Word file of your manuscript. Keep the image files (if any) separate from your main document file with instructions of how and where you want the images placed. (300dpi) Once you have finished making changes to your manuscript, email it as an attachment to us at support@slabypress.com, or copy it onto a CD and mail it to us at one of the addresses at the top of this page.

Proof: First, a pdf. print is sent to you for any changes, after your approval, a hard copy of the book is mailed to you. After approval of the hard copy we print the book.

Printing / Binding: Perfect binding is used for most trade books. (Minimum 65 pages) Spiral, plastic comb and saddle stitch (staple) are other methods for binding a book.

ISBN: We give your book an ISBN number so it can be sold in stores and online.

Distribution: Your book is listed on our web site. Distributors/wholesalers ask for a 55% discount on the list price, which reduces the royalty, but book shops and stores buy books through distributors. Your ISBN number and book will be listed in Bowkers, Books in Print.

Promotion / Marketing: The Author plays an important role in marketing, by promoting the book at signings, book fairs, or trade shows, etc. We cannot guarantee or promise success.

Royalty: Author shall receive royalties equaling 50%. The royalty is calculated after all discounts to distributors/wholesalers and all production costs are applied.

Book Purchases: The Author can purchase copies of the printed work (50 copies minimum) at cost, plus handling and shipping. Book purchases are non-returnable.

Right of Refusal: The Publisher reserves the right to refuse any submitted material for any reason at any time at its sole discretion. In no event shall the Publisher be obligated to publish a work, which in its opinion violates copyright, the right of privacy of any person, or contains libelous or material.

Publishing Agreement

This is a PUBLISHING AGREEMENT between SLABYPRESS (Publisher), and the author named in this contract. Effective on the date signed, the Publisher and Author mutually agree as follows:

A. License of Rights

The Author hereby grants the Publisher, during the Term of this Agreement, the nonexclusive international rights including, publishing, distribution of the book, and promotion of author. This Agreement shall begin on the Effective Date and extend indefinitely until terminated by Author and Publisher.

B. Permission for Copyrighted Material

If the Author incorporates in the Work any copyrighted material, he/she shall procure, at his/her expense, written permission to reprint it. The Author agrees to retain all such written permissions. The Author agrees to deliver all such written permissions to the Publisher at the Publisher's request.

C. Author's Warranties and Indemnities

The Author represents and warrants to the Publisher that he/she is the sole owner of the work and of all the rights granted to the Publisher. That the work is entirely original except for portions thereof for which legally effective written licenses or permissions have been secured. That the work does not infringe upon any copyright, that any information contained in the work is accurate, and any recipe, formula, or instruction contained in the work is not injurious to the reader or to any other party. The Author shall hold harmless the Publisher, any seller of the Work, and any licensee of a subsidiary right to the Work, against any damages finally sustained. If such claim, action, or proceeding is successfully defended or settled, the Author shall indemnify the Publisher against the entire expense. The Publisher may withhold payments of reasonable amounts due the Author under this or any other agreement between the parties. These warranties and indemnities shall survive the termination of this Agreement.

D. Copyright Notice

All copies of the work distributed to the public shall bear a copyright in the name of the Author.

E. Royalty Payments

The Author shall receive royalties equaling 50% of the Book Receipts from the sale of printed copies of the Work. "Book Receipts" is defined as the payments the Publisher actually receives from the sales of printed copies of the Work, less any returns. No royalty shall be paid on copies sold below or at cost, including expenses incurred; for review, advertising, sample, or like purposes. The Publisher will make royalty payments on a yearly basis to the Author. If the Author has included the work of other authors in the work, the royalty payment made by the Publisher to the Author shall not be increased and shall include the royalties due to such other authors. It is the responsibility of the Author to pay such other authors the pro-rated portions of the royalties to which they are entitled. Should the Author receive an overpayment of royalty arising from copies reported sold but subsequently returned for reason other than physical defect, the Publisher, may deduct such overpayment from any future royalties due the Author.

F. Suits for Infringement of Copyright

If the copyright of the Work is infringed and the parties (the Author and the Publisher) proceed jointly, the expenses and recoveries, if any, shall be shared equally, and if they do not proceed jointly, either party shall have the right to prosecute such action, and such party shall bear the expenses thereof, and any recoveries shall belong to such party; and if such party shall not hold the record title of the copyright, the other party hereby consents that the action be brought in his/her name.

G. Contract

When signed this contract constitutes an agreement between the Publisher and Author, and is effective until terminated by the Publisher and Author.

Book purchases

The Author can purchase copies of the printed work (Minimum-50 copies) at cost, plus shipping and handling.

Book Cost is calculated by page count and book size. After we know the page count and dimensions, we calculate the book cost. The **List Price** is placed on the back cover of the book with the ISBN number barcode. To calculate the list price, multiply the book cost by three. **Book Cost X 3 = List Price.**

The Author can set a lower List Price, but this will decrease Royalty payments.
